RESOLUTION AMENDING ZONING ORDINANCE

TO THE MARATHON COUNTY ENVIRONMENTAL RESOURCES COMMITTEE
RESOLUTION NO. 2022-02

WHEREAS, the Town of McMillan Town Board and Plan Commission with public input has reviewed, amended and adopted a Comprehensive Plan December 13, 2021 by ordinance.

WHEREAS, the Town of McMillan Town Board and Plan Commission received requests from property owners to reclassify zoning of parcels; and

WHEREAS, the Town of McMillan Town Board and Plan Commission also received request to reclassify zoning of parcels a list of which was received from Wisconsin DATCP

WHEREAS, the Town of McMillan Plan Commission with Town Board and representatives from Marathon County Conservation Planning & Zoning held public meetings and open houses to give land owners an opportunity to review drafts and finalize property lists and maps

WHEREAS, Section 59.69(5)(e)3., Wisconsin Statute, provides that if a town affected by a proposed amendment disapproved of the proposed amendment, the town board may file a certified copy of a resolution adopted by such board disapproving of the petition with the Environmental Resources Committee prior to, at or within ten (10) days after the public hearing, and

WHEREAS, if the town board of the town affected in the case of an ordinance relating to the location of boundaries of districts files such a resolution, the Environmental Resources Committee may not recommend to the County Board approval of the petition without change, but may only recommend approval with change or recommend disapproval.

WHEREAS, the Town of McMillan Plan Commission at a special meeting called on January 7, 2022 held at the Town Hall with all commission members present and one attending via teleconference found the petition of rezone to be in compliance with the Town of McMillan Comprehensive Plan and unanimously recommends to the Town Board approval of the list of parcels and property owners and maps addendum to this resolution


NOW, THEREFORE, BE IT RESOLVED the Town Board of the Town of McMillan, Marathon County, Wisconsin considered on the 10th day of January, 2022 a petition of the Town of McMillan to amend the Marathon County Zoning Ordinance to rezone lands as defined in the addendum (Addendum List McMillan County List Rezones Dec2021 and Town of McMillan Zoning Draft Map Jan2022) and finding compliance with the Town of McMillan Comprehensive Plan.


